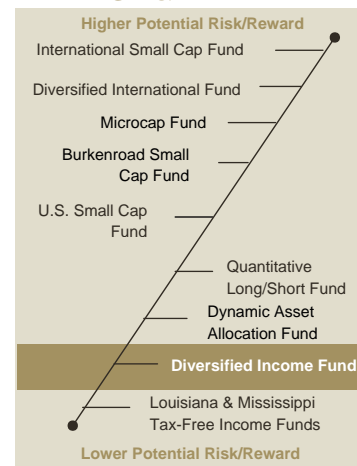

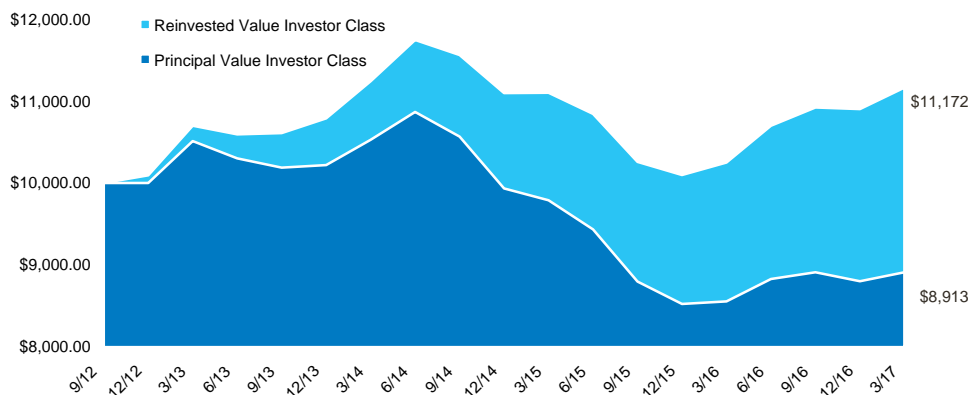
FUND OBJECTIVE
