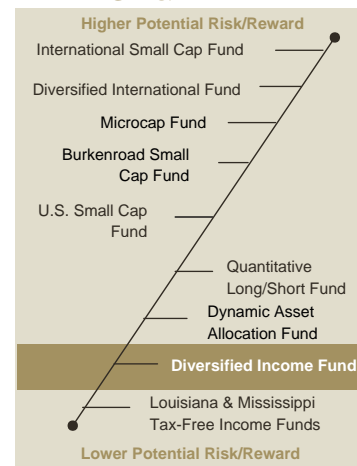

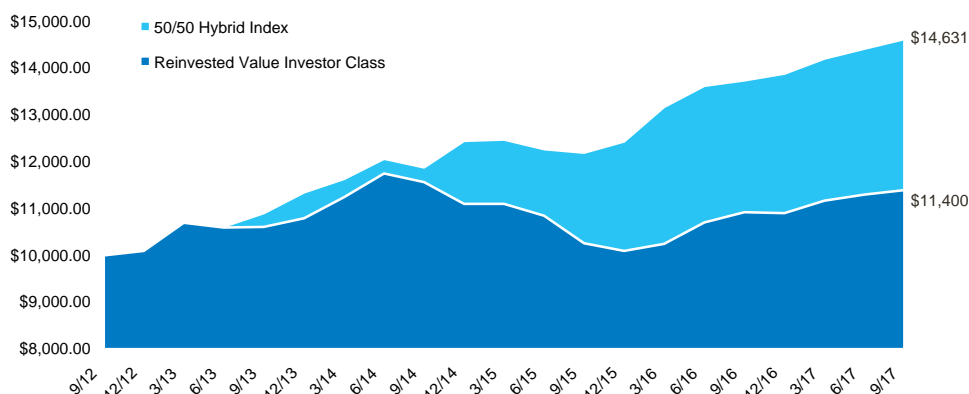
FUND OBJECTIVE
