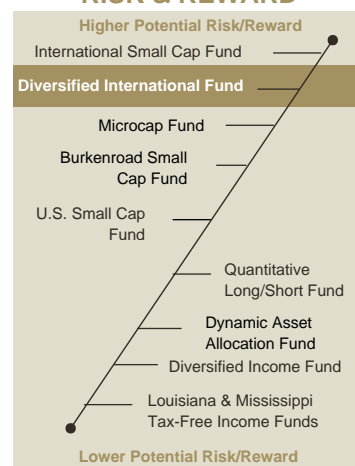

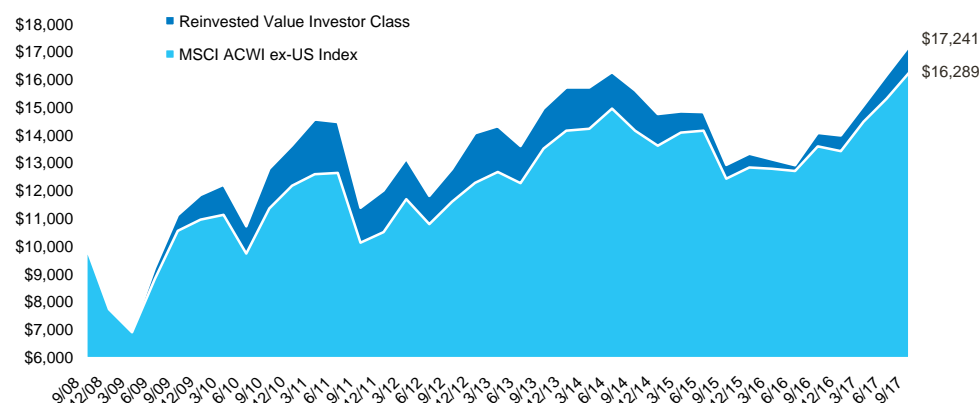
FUND OBJECTIVE
