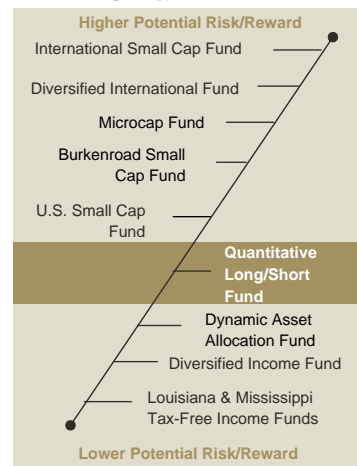

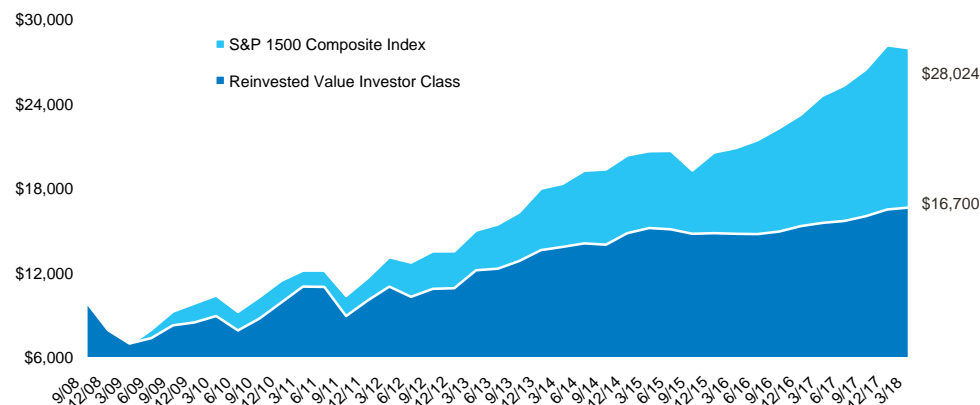
FUND OBJECTIVE

The Fund seeks long-term capital appreciation by taking long and short positions in equity securities of publicly traded companies in the U.S. primarily included in the S&P Composite 1500 Index. Using a quantitative model developed by the Adviser, the Fund buys stocks "long" that it believes are undervalued relative to their peers, and sells stocks "short" that the Adviser believes are overvalued relative to their peers.

The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. HHQAX, HHQTX and HHQCX were rated against 191 Long/Short Equity funds over a three-year period and 101 funds over a five-year period. With respect to these funds, HHQTX and HHQAX received a rating of 3 stars for the three-year period and 4 stars for the five-year period.
